Essex County Council has notified of a road closure for three days commencing 18<sup>th</sup> June between Fitzjohns Lane and Hellmans Cross, required by Affinity Water.

The parish beacon was lit on Thursday 6<sup>th</sup> June at 9.15pm to mark the 80<sup>th</sup> anniversary of the D-Day landings.

There has been no further progress with Kemi Badenoch MP on either Crumps Farm or the byway issues. With a general election called on 6<sup>th</sup> July and parliamentary boundary changes for Great Canfield, it will be necessary to re-engage post 6<sup>th</sup> July with whoever the MP is for Great Canfield which will be in the Harlow constituency.
